Income Tax Return, xerox copy of voter card, xerx copy of adhar card, Profession Tax Registration Certificate with current challan and Trade Registration
- ω Bidders must submit Credential and Completion Certificate in similar nature of work during last three years
- 4 In case of bid/tender emanating from cartelization of bidders, entire tender process will be cancelled.
- 5) Bidders must quote rates in absolute numerical values (both in figures and words) and percentage against the estimated cost.
