Intending contractors shall drop their separate sealed Tender Forms duly filled up along with attested photocopies of up to date and valid Income Tax, GST (UPDATE), Professional Tax clearance certificate and credential certificate (i.e. payment certificate & completion certificate), issued from Govt. or Semi Govt. authority or Local Self Govt. for an amount not less than the amount, as shown in the above table, only said nos. of work for the same and similar type of work done in the last three years, within 10/02/2022 to 11/02/2022 upto 2.00 P.M. at the office of Gram Panchayat.
