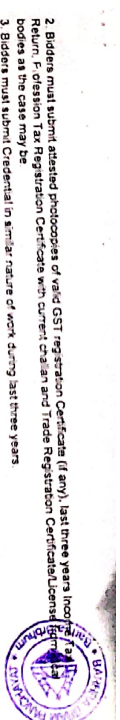

- Bidders must submit attested photocopies of valid GST registration Certificate (if any), last three years Income Tax Return, P. F. deputation Tax Registration Certificate with current challan and Trade Registration Certificate/ Licensed bodies as the case may be.
- Bidders must submit Canceled in similar nature of work during last three years.
- In case of bidder emanating from categorization of bidders, entire tender process will be cancelled.
- Bidders must quote rates in absolute numerical values (both in figures and words) and percentage against the estimated cost.
- Rate offered by a bidder in a particular Tender shall be treated as final and subsequent negotiation with that bidder for change in price shall not be allowed.
- Multiple bids (more than one bid by same bidder) and variable rates (different rates of same item by same bidder) shall be rejected outright.
- No special preference in respect of Earnest Money, Security Deposit etc. will be given to any Cooperative Society/Government owned Company/Government Undertaking/Cooperative etc. In other words, all participating Bidders will be treated on equal basis only and no favourable special considerations will be accorded to any bidder.
- Bidder must submit sealed envelope clearly mentioning serial number and name of work on top of the envelope.
- Earnest money should be deposited in Cash/Chitragu Bank Draft or Government Bond/Securities duly pledged in favour of the Pradhan, Barbra Gram Panchayat and will be refunded/credited as the case may be. In case of Cash/Chitragu Bank Draft, the bidder must collect money receipt (in Form-5) from Gram Panchayat office and quote the number in tender form. In case of Government Bond/Securities, respective pledged documents need to be submitted along with Sealed Tender.
- Successful Bidder (s) will be required to lodge security deposit (10% of the total value of the work as quoted by him) as performance security in the form of Cash/Chitragu Bank Draft/Government Bond/Securities duly pledged in favour of Pradhan, Barbra Gram Panchayat of the amount may be deducted from every running payment (not exceeding three months) during the final bill made and will be released 6 months in case of Building, Civil and Concrete Roads and 3 months in all other cases.
- GST, ITDS and Labour Cess will be deducted as per existing rates fixed by the respective department of the government.
- Pre-bid conference/meeting with the prospective Bidders will be held on ..... at ..... pm (not later than 4 days before the last date of submission of Tender). Environmental and Social Safeguards issues pertaining to the tendered work will also be discussed and explained in the meeting.
- Site visit may be done by the bidders at their own cost.
- Erroneous or incomplete Tender Form will be summarily rejected without assigning any reason whatsoever.
- Contractors may be asked to submit rate analysis for items where the quoted rates are either below or above 5% than the estimated rate. Such bids may also be considered as null and void if there is a reason to believe that the Bidders have tampered a contract and rates have been manipulated, unbalanced or unreasonable.
- Successful Bidder will have to execute a formal contract on a Non-Judicial Stamp paper within seven days from the receipt of 'Letter of Acceptance' with the Gram Panchayat whenever the description, specification, quantity, date of completion of work or other mandatory conditions and ESMP (Environmental and Social Management Framework) issues shall be detailed. Failure to execute the contract will lead to automatic cancellation of the bid.
- The undersigned is not bound to accept the lowest tender and reserves the right to accept or reject any or all tenders, as the case may be without assigning any reason whatsoever.
- Quoted rate shall be inclusive of all charges including royalty, GST, local charges, transportation etc.
- Any bid received from the bidder without authentication of correction made in rate quoted in word or figure shall lead to cancellation of the bid.
