- 2. Bidders must submit at tested photocopies of valid GST registration Certificate, last three years Income Tax Return, Profession Tax Registration Certificate with current challan and Trade Registration Certificate/License from local bodies as the case may be.
- 3. Bidders must submit Credential in similar nature of work during last three years.
- 4. In case of bid/tender emanating from cartelization of bidders, entire tender process will be cancelled.
- 5. Bidders must quote rates in absolute numerical values (both in figure sand words) against the estimated cost. Rate quoted in percentage term will be rejected.
- 6. Rate offered by a bidder in a particular Tender shall be treated as final and subsequent negotiation with that bidder for change in price shall not be allowed.
- 7. Multiple bids(more than one bid by same bidder)and variable rates(different rates of same item by same bidder)shall be rejected out right.
