#### Annexure-C

## Technical specification for Tube Well

- The whole of the work and materials shall conform to the current edition of relevant Indian standards and PWD(W.B) Schedule of rate 1
- The contractor shall keep on site a complete record with if any changes, such records shall be made available for inspection by the engin 2 work.
- The contractor will be responsible for any claims arising from damage to services or to adjacent structures or property, at the time of execution 3
- After the tube well has been installed in its final position, the engineer will inspect the tube well for proper plumb, location and other condition, only after 4 his/her approval can the contractor proceed the work
- Suitable drain should be provided to prevent stagnation of water and it should be connected with suitable out falls for the disposal. 5
- Location of the tube well must be at least 15 meters away from soak pit and other sanitation facilities. 6
- Provide a concrete Platform of sufficient thickness for 75cm radius around the tube well to seal the outer periphery. 7
- 9 Water testing should be necessary, water testing shall be done at the time of tube well installed.
- Provide permanent signboard at the site with all specification 10
- All the concrete shall be machine mixed & the concrete mixer shall be clean at all times. 11
- The concrete shall be placed in its final position as soon as possible and in any case not later than half an hour after mixing. 12
- The concrete shall be transported from the mixer to the position of placing in such a manner that segregation of the mix shall not occur. 13
- 14 Suitable side drains should be provided to prevent stagnation of water and it should be connected with suitable out falls for the disposal.
- Not be permitted to walk over freshly placed concrete until it has hardened sufficiently to carry their weight without distortion, also to Barricade the road from 15 both of the end till initial setting of the concrete.
- The Form work must be uniform in length & be removed after 12 hours of completion of casting. 16
- Expansion joints shall be provided at an interval of 10mtr apart and it should be perpendicular to cross section of road. 17
- 18 Camber shall be provided maximum 2.5% for Rigid Pavement.
- 19 Following the curing period, keep wet continuously for not less than seven(7) days after being removed from the forms. According to order vide no. 594/ISGPP/20E-2(Proc)/39 the Gram panchayats are allowed to utilize 0.5% of estimated value of a scheme out of block grant of ISGPP Project for meeting unforeseen expenditure(Contingency) and for monitoring and supervision of schemes
