Special Terms & Condition of this Tender:-

A. The tenderer will have to submit their bid **on-line** in two folder system containing pre qualification document, **Technical bid** in one and **Financial Bid** in another.

B.The detailed tender notice along with Tender Documents and other forms is available at https://wbtenders.gov.in website .

C.Earnest Money Deposit (EMD) should be deposited as per mention annexure A column 6 in form of DD in favour of ProdhanBhromorkole Gram Panchayat payble at ahmadpur. The scan copy of DD must be uploaded in portal & original DD copy should be submit to undersign office within 26/05/2023 upto 3 pm.

D. Similarly the e tender processing fee (Non – Refundable) as per annexure A, Col .7 should be deposited in form of DD in favour of Prodhan Bhromorkole Gram Panchayat payble at Ahmadpur. The scan copy of DD must be uploaded in portal & original DD copy should be submit to undersign office with in 26.05.23 upto 3 pm.

D-i). No special preferences in respect of Earnest Money, processing fee, Security Deposit etc. will be given to any Cooperative Society/Government owned Company/Government Undertaking/Corporation/ Engineering Cooperative etc. In other words, all participating Bidders will be treated on equal basis only and no favorable/special considerations will be accorded to any bidders.

E. The BOQ sheet in excel format should be filled up properly .Bidders must quote rates in Percentage basis upto two decimal only. Rate offered by a bidder in a particular Tender shall be treated as final and subsequent negotiation with that bidder for change in price shall not be allowed. Quoted rate shall be inclusive of all charges including royalty, GST, tools charges, transportation etc.

F) The Agency shall quote their rate in percentage basis i.e. Excess /Less/At par numerically and write in word in the given space of Financial Bid Documents (BOQ) only. If it found that any bidder(s) quoted/marked his/her rate anywhere other than BOQ, his/her bid will be rejected outright.

G) Following documents with self attested should be uploaded to participating e tender:-

- 6) Bidders must submit min **100% for PBG works& 60% for 15th FC fund**, Credential in similar nature of work with respective work order copy during last three years.(ie-Fy 2020-21)

H) During the scrutiny if it comes to notice of the tender inviting authority that the credentials or any other paper found incorrect/manipulate/fabricated that bidder would not be allowed to participant in the tender and that application will be rejected without any prejudice.

I) All documents in proof of their eligibility in Original need to be produced by the bidders as and when asked & required by this office

J) Before the deadline for submission of bids, the Authority may modify the bidding documents by issuing addenda/corrigenda as well as after closing of the bid submission date, the Authority may extend the bid submission date, if found minimum bids not receipt.

K). Irrelevant documents must not be uploaded. (This may cause disqualification in technical bid).

L) Bidder(s) may be asked to submit rate analysis for items where the quoted rates are either below or above 35% than the estimated cost. Such bids may also be considered as null and void if there is a reason to believe that the Bidders have formed a cartel and rates have been manipulated, unbalanced or unreasonable.

M) Canvassing in connection with the tender is strictly prohibited in the Tender submitted by the Contractor.

N) Time is the essence of contract. The successful contractor must complete the work within the time specified for completion. **No. Extension of time will be allowed** except in special case. If any contractor fails to complete the work within the stipulated time the work order issued in his favour will be cancelled without assigning any reason thereof. The undersigned may also proceed to get the balance work completed by any other means including through other contractors. The excess expenditure, if any, due to such a step would be recoverable from the unpaid Bills/Security deposit of the Tenderer. This is the apart from the penal measure the undersigned may take, including, Blacklisting of the contractor and forfeiture of Earnest Money.

O) Contractor'(s) will have to comply with the provisions in connection with Labour, Apprentice, Minimum Wages etc. stated under premailing Government Act(s) and Norms(s) as applicable.

P) The contractor shall not be entitled for any compensation for any loss suffered by him due to delay arising out, modification, due to non-delivery of the possession of site and / or notification of drawing and design.
