

Higibility criteria for participating in e-tender.

2. The bidder shall have satisfactory completed as prime agency during the last 3 years from the date of issue of this notice at least one work of similar type for as specifically mentioned in the eredential column under the authority of State/Central Govt under taking summtory bodies constituted under the statute of the Central / State Govt, and having a magnitude of 40 (forty)% of the amount put tender. The completion certificate and details communicational address of the client must be indicated in the credential certificate (Non-Statutory Documents).



- 3. P. Tax deposit challan for upto date. PAN card, GST Registration Certificate has to be accompanied with the technical Bid document (Non-Statutory Documents). The agency should also have to deposit the IT return certificate for the last three financial
- 4. Registered Partner Ship Deed in case of partnership firm has to be submitted. The Company shall furnish the Article of Association and Memorandum. Where an individual person holds a digital certificate in his own name duly issued to him against the company or the firm of which he happens to be a director or partner, such individual person shall, where uploading any tender for an on behalf of company or firm invariably upload a copy of registered power of attorney showing clear authorization in his favour, by the rest of director of such company or the partners of such firm to upload such tender (non Statutory Documents).
