1. The Payment of cost of Tender Paper will be received in Cash (See Annexure for cost of Tender Paper).
2. Xerox & attested copies of current Trade Registration Certificate, Sales Tax and professional Tax clearance certificates, Sales Tax and professional Tax Clearance Certificates, PAN Card and VAT/GST Registration Certificate having
3. VAT/GST No. written thereon must attached with the application.
4. Tender Amount should be quoted in absolute terms (Instead of Above/ At par/ Less than the scheduled rate) both in figures and in words.
5. ESMF guidelines will strictly followed at the time of work i.e. A) No child labour should be engaged in the work. B) No vulnerable and backward class/ caste should be exploited. C) The work should not do any harm to Environment.

In case of successful tenderer 10% (Ten Percent) security money will be deducted from each successive bill and in that case earnest money (2.0%) already deposited will be taken into account. Earnest money of first successful tender and second successful tenderer will be retained upto the period which the Gram Panchayat decide. The tender from will be duty filled in and signed by the applicant by his own hand writing. Each contractor/ Supplier will submit the application of his name only.
