1	The applicant in the same name and style as prime contractor should have successfully completed same nature of works at least 60% (Sixty Percent) value of the proposed contract within the last 5 years. Tenderers must submit the Credential of both i.e Civil work and Electrical work.
2	Income Tax return should be uploaded for the last 3 (three) year with the Technical Bid.
3	Photo copy of Professional Tax Deposit Chalan along with enrollment Certificate, GST registration Certificate & PAN Card should be uploaded. The bidders are requested also to visit the web page of the tender since the starting date of downloading documents so as they may submit the documents as sought for by the authority of this Panchayat.
4	All bidder deposit the Earnest Money Deposit (i.e. Demand Draft) to the NS of Ahmadpur Gram Panchayat as mentioned against each work at the time of signing agreement. All duties, taxes, royalties, cess, toll taxes and other levies payable by the contractor under the contract to the State/ Central Government for any other cause, shall be included in the rates prices and total Bid Price submitted by the bidder.
6	The undersigned reserves the right to reject any or all tenders without assigning any reason what so ever at any stage.
7	All works will be have to be done according to specification and drawing approved by the authority and as per direction of the concerned officer of this Panchayat.
8	Before submission of tender, the contractor may visit the work site to judge the local condition from all corners and no please Complain about the site will be entertained after wards. It will assumed that the agency offered the tender rate after reviewing entire position of the work site.
9	Time is the essence of contract. The successful contractor must complete the work within the stipulated time. No extension of time will be allowed except in special cases. If any contractor fails to complete the work within the stipulated time the work order issued in his favour will be cancelled without assigning any reason and penal measure will be taken against him as per existing rules.

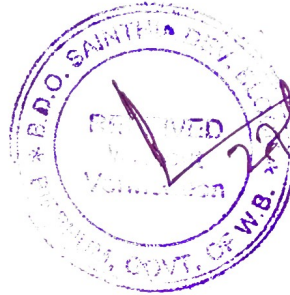
