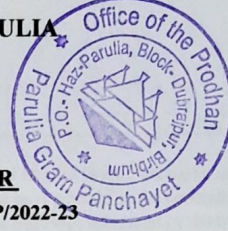



6	All works will be have to be done according to specification and drawing approved by the authority and as per direction of the concerend N.S. of this Panchayat.

9	Payment will be made as per availability of fund.


