

No extension time for completion will be allowed without valid reasons. Penalty will be imposed as per rules if the Supply is not completed with the schedule time.

No measurement will be taken until 65% of supply of work is completed.

All working tools and plants implements , transport cost required for the supply are to be arranged and supplied by you, at your own cost. No consumable materials will be supplied to the agency or any work from the office of undersigned. Agency will be responsible for producing all materials require for proper execution of work at his won cost. No transport cost will , No labour Cost of loading and unloading of supply material at the time of supply at office go down will be given from undersigned.

You will have to abide by the provisions of west Bengal contract Labour (Regulation and Abolition) Rules, 1972 as will be forced from time to time.

After completion of the work, payment shall be made as per rates approved and as per measurement recorded in the M.B./ Sheet by the STP /Nirman Sahayak, deducting such as IT, ST/VAT , Royalty Labour cess, surcharge and other deduction as prescribed by the Government from time to time .

Under signed reserves the right to accept or to reject any or all the tender and to get part work done by engaged contractors without assigning any reason, payment will be made as per availability of fund .

A office Staff will remain present during Supply period for unloading the material in proper position .
