Terms & Conditions:-

- 1. Cost of Tender from(non-refundable)has to be paid in cash only.
- 2. Bidders must submit attested photocopies of valid VAT registration certificate (if any), last three years income TAX Return, profession Tax Registration Certificate with current challan and Trade Registration certificate/License from local bodies as the case may be and also produced original documents for verification.
- 3. Bidders must submit Credential in similar nature of work during last three years.
- 4. In case of bid/tender emanating from cartelization of bidders, entire tender process will be cancelled.
- 5. Bidders must quote rates in absolute numerical values(both in figures and words)against the estimated cost. Rate quoted in percentage term will be rejected.
- 6. Rate offered by a bidder in a particular tender shall be treated as final and subsequent negotiation with that bidder for change in price shall not be allowed.
- 7. Multiple bids (more than one bid by same bidder) and variable rates (different rates of same item by same bidder) shall be rejected outright.
- 8. No special preferences in respect of Earnest money, Security deposit etc. will be given to any cooperative society/Government owned Company/Government undertaking/Corporation/Engineering cooperative etc. In other words, all participating Bidders will be treated on equal basis only and no favorable/special considerations will be accorded to any bidders (applicable only for ISGP Block Grant). Enlisted contractors may apply without Earnest Money.
- 9. Bidder must submit sealed envelope clearly mentioning serial number and name of work on top of the envelope.

 10. Earnest money should be deposit in cash/cheque/Bank Draft/or Government Bond/Securities duly pledged in favour of prodhan Kalitha Gram Panchayat and will be refunded/ forfeited as the case may be . In case of cash/cheque/bank draft, the bidder must collect receipt from Gram Panchayat Office and quote the number in Tender Form. In case of Government Bond /securities respective pledged documents need to be submitted along with seald Tender.

Successful Bidder will have to execute a formal agreement on a Non-Judicial Stamp paper within seven days from the receipt of "Letter of Acceptance" with the Gram Panchayat wherein the description specification quantity date of completion of work other mandatory conditions and ESMF(Environmental and Social Management Framework) issues shall be detailed. Failure to execute the contract will lead automatic cancellation of the bid.

Annexure-C

Technical specification for Culvert & Drain

- 1. The whole of the work and materials shall conform to the current edition of relevant Indian standards and PWD(W.B) Schedule of rates (Road & Bridge works 2008-9,6th, 7th corrigendum).
- 2. The contractor shall keep on site a complete record with if any changes, such records shall be made available for inspection by the engineer during executing the work.
- 3. The contractor will be responsible for any claims arising from damage to services or to adjacent structures or property, at the time of executing the work.
- 4. The contractor responsibility to protect existing structures and utilities from damage or interruption of services due to
- 5. The contractor shall provide a skilled person for supervision of all construction work accordance with the drawing and
- 6. Reinforcing bar should be deformed bars for all Reinforced Cement Concrete (RCC) work, and should have Thermo Mechanically Treated (TMT) and minimum yielding strength of 414 n/mm2.
- 7. Cement shall be Portland & specified used as soon as possible after delivery, any cement that has been stored for a period accessing 3 months shall not be used until it has been tested for suitability.
- 8. Fine aggregate (Sand) shall be clean sharp, coarse & well graded free from soft particle, clay, shell or any other deleterious
- 9. Coarse aggregate (jelly or stone) the combined coarse aggregate shall be suitable for making a dense concrete of appropriate workability with the proportions of cement and water with which the aggregate is to be used also the aggregate shall be well graded and free from dust, dirt & nuisance.
- 10. Bricks shall be locally available or equivalent and be hard, well baked and shall have an uniform and sufficient compressive strength and the shape shall be rectangular.
- 11. Mixing water shall be clean and free from oil, acids, alkalis, salt, organic material or substance which may deleterious to
- 12. All the concrete shall be machine mixed & the concrete mixer shall be clean at all times.
- 13. The concrete shall be placed in its final position as soon as possible and in any case not later than half an hour after mixing.
- 14. The concrete shall be transported from the mixer to the position of placing in such a manner that segregation of the mix
- 15. Surface finishing should be smooth, nozzle vibrator must be used for RCC & PCC work, small surface holes caused by air bubbles, normal form joint marks, and minor chips and spalls will be tolerated, but no major unsightly imperfections, honeycomb or structural defects will be permitted.
- 16. Spacing block shall be used to insure accurate cover to the reinforcement, where necessary, and these blocks shall precast concrete they shall be as small as possible.
- 17. Following the curing period, keep wet continuously for not less than seven(7) days after being removed from the forms.
- 18. According to order vide no. 594/ISGPP/20E-2(Proc)/39 the Gram panchayats are allowed to utilize 0.5% of estimated value of a scheme out of block grant of ISGPP Project for meeting unforeseen expenditure(Contingency) and for monitoring and
