

- 2. Bidders must submit attested photocopies of valid GSTN registration Certificate, last three years Income Tax Return.

- 3. Bidders must submit Trade licence
- 4. In case of bid/tender emanating from cartelization of bidders, entire tender process will be cancelled.
- 5. Bidders must quote rates in absolute numerical values (both in figures and words) against the estimated cost. Rate quoted in percentage term will be rejected.
