Tender Form along with relevant documents has to be purchased from the Gram Panchayat Office.

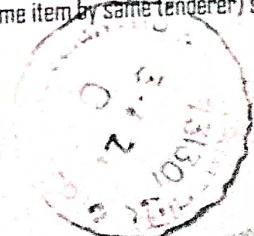
N.B. - If the office remain closed in any unavoidable circumstances on above-mentioned any days, then next working will come into force & the scheduled time will remain unchanged. Original certificates or documents as specified in Annexure-B (no. 2&3) must be produced on demand at any stage of tender procedure.

Annexure-B Term & Conditions:- Cost of tender form (non refundable) has to be paid in cash only.

1. Tenderer must submit attested copy of valid GST registration Certificate, last three Income Tax Return, Profession Tax Registration Certificate with Current Challan and Trade registration certificate/License from local bodies as the case may be.
2. Tenderer must submit Credential in similar nature of work during last three years.
3. In case of bid/tender emanation from cartelization of bidders, entire tender process will be cancelled
4. Tenderers must quote rate in absolute numerical values (both in figures & word) against the estimated cost. Rate quoted in percentage term will be rejected.
5. Rate offered by a tenderer in a particular Tender shall be treated as final and subsequent negotiation with that tenderer for change in price shall not be allowed.
6. Multiple bid (more than one rate by same tenderer) are variable rates (different rates of same item by same tenderer) shall be rejected outright.


7. No special preferences in respect of earnest money, security deposit etc. will be given to any cooperative society/Government owned Company/Government Undertaking/Corporation/Engineering Cooperative etc. in other words, all participating tenderer will be treated on equal basis only and no favourable/ special consideration will be accorded to any bidders (Applicable only for ISGP Block Grand). Enlisted contractor may apply without earnest money.
8. Tenderer must submit sealed envelope clearly mentioning serial number and name of work on top of the envelope.
9. Earnest money should be deposited in cash/cheque/bank draft of Government Bond/Securities duly pledged in favour of the PRADHAN CHARKALGRAM GRAM PANCHAYAT and will be refunded/forfeited as the case may be. In Cash/Cheque/Bank Draft, the tenderer must collect receipt from Gram Panchayat Office and quote the number in Tender Form. In case of Government Bond/Securities respective pledged documents need to be submitted along with sealed Tender.
10. Successful tenderer(s) will be required to lodge security deposit (10% of the total value of the work as quoted by him) as performance security in the form of cash/cheque/Bank draft/Security duly pledged in favour of the pradhan, Charkalgram Gram Panchayat or the amount may be deducted from every running payment (not exceeding two including the final bill) made and will be released after 3 months in all cases except ISGP Block Grand where it will be released after 6 months in case of building, culvert and concrete road and 3 months in all other cases.
11. GST, TDS and applicable Cess (if any) will be deducted as per existing rates fixed by respective department of the Government.
12. Environmental and social safeguards issues pertaining to the tendered work will also be discussed and explained in meeting.
13. Site visit may be done by the bidders at their own cost.
14. Erroneous or incomplete Tender Form will be summarily rejected without assigning any reason whatsoever.
15. Tenderer(s) may be asked to submit rate analysis for items where the quoted rates are either too high or low than the estimated cost. Such bids may also be considered as null and void if there is a reason to believe that the bidders have formed a cartel and rates have been manipulated, unbalanced or unreasonable.
16. The undersigned is not bound to accept the lowest tender and reserves the right to accept or reject any or all tenders, as the case may be without assigning any reason whatsoever.
17. Quoted rate shall be inclusive of all charge including royalty, IT, tools charges, transportation etc.
18. Any rate received from the without authentication of made in rate quoted in work or figure shall lead to cancellation of the rate.
