The tenderer will have to submit their bid on-line in two cover/folder system containing prequalification document(Technical Bid)in one and Financial Bid in another. 3) Technical Bid Documents should be accompanied with copies of tenderer's i) PAN Card, (ii) Professional Tax Receipt / Chalan for the current year, (iii) GST return (iv) Income tax Returns for last 3 (Three) years v) Enrolment certificate (vi) Trade Registration Certificate / License from local bodies as the case may be.

TERMS AND CONDITIONS

11. The payment (Amount) received by the agency for any work completion from any authority (Govt. / Semi-Govt) within a financial year should be treated as credential of the agency for that financial year and total payment receive amount for particular type of work in a financial year should be treated as his credential for that particular type of work.
12. The tenderer / quotationer who will apply for construction work they should submit sufficient experience certificate for doing such type of work and that will be certified by competent authority.
13. Financial Bids of those tenderers who qualify in Technical Bid will only be opened. Dates, if changed, due to unavoidable circumstances, will be published in the said website and the office notice board only without any individual intimation.
12. Before submission of tender, the tenderers are requested to inspect the site & get themselves acquainted thoroughly with the work site / local condition. It will be presumed that the agency offered the tender after reviewing entire position of the worksite. Site visit may be done by the bidders at their own cost.
14. The selected agencies for Tender/Quotation should deposit the application fees and EMD of Tender/Quotation during the time of submission of original copies of tenders documents.
15. No cost of bidding shall be reimbursable by the Office of the Prodhan, Baraturigram Gram Panchayat. This Tender procedure may be cancelled at any stage without assigning any reason thereof. Decision of the undersigned regarding cancellation / modification etc. of this tender is final. Authority may accept or reject any tender without Assigning any reason whatsoever.
16. The willing tenderers may remain present at the time of Opening of Tender.
17. The Prodhan, Baraturigram Gram Panchayat reserves the right to cancel the e-NIT due to un-avoidable circumstances and no claim in this respect will be entertained.
18. A tenderer's bid will be out rightly rejected with a forfeiture of his earnest money if it comes to the notice of the Tender Inviting Authority scrutiny that the credential or any other paper of a tenderer are manufactured, fabricated, etc.
19. The Tender Inviting Authority may verify the original credential or other original documents of the lowest tender, if found necessary, before issuance of the Work Order and the work order will not be issued in favour of the tenderer if it found on verification that such documents submitted by him is either manufactured or fabricated etc.
20. Evaluation of Technical & Financial Bid will be held at the Chamber of the Prodhan, Baraturigram Gram Panchayat as mentioned in Para 11 of this NIT.
21. In case of successful tenderer 10% (ten percent) security money will be deducted from each successive bill and in that case earnest money (2.0%) already deposited will be taken into account. Earnest money of first successful tenderer and second successful tenderer will be retained up to the period which the Gram Panchayat will decide. And security money will be released after 3 months in all cases except ISGPP Block Grant where it will be released after 6 months; in case of Building, Culvert and Concrete Roads and 3 months in all other cases.

- BID validity laid upto 180 days from the date of issue of this order.
23. Work should be completed in scheduled time. Otherwise the contract agreement will be cancelled without prior intimation. Work should be completed as per estimate. Payment will be made as per work done.
24. Successful tenderer must execute an agreement on Non-Judicial Stamp paper worth Rs. 10.00 only within seven days from the receipt of "Letter of Acceptance" with the Gram Panchayat. And must maintain all the terms and conditions as laid down in the NIT and in the Tender form as well as satisfactorily. Cost of Stamp paper will be born by the agency. Failure to execute the contract will lead to automatic cancellation of the bid.
25. Acceptance of the lowest tender is not obligatory and the undersigned reserves the right to accept or reject any or all the tenders without assigning any reason whatsoever and also to split up the tendered work to more than one contractor / supplier in the interest of scheme execution.
26. Quoted rate shall be inclusive of all charges including royalty, GST, tools charges, transportation etc. Any bid received from the bidder without authentication of correction made in rate quoted in word or figure shall lead to cancellation of the bid.
27. Bidder(s) may be asked to submit rate analysis for items where the quoted rates are either abnormal below or above than the estimated cost. Such bids may also be considered as null and void if there is a reason to believe that the Bidders have formed a cartel and rates have been manipulated, unbalanced or unreasonable.
28. No special preferences in respect of Earnest Money, Security Deposit etc. will be given to any Cooperative Society/Government owned Company/Government Undertaking/Corporation/ Engineering Cooperative etc. In other words, all participating Bidders will be treated on equal basis only and no favourable/special considerations will be accorded to any bidders.
29. The undersigned also reserves the right to forfeit the earnest money and security money, if the work is not completed within the stipulated "Completion period" and also reserves the right to cancel the work order forth right.


