The Sealed Tenders will be opened on the same day i.e. on 23/07/2022, after 2 P.M. in presence to the contractors, who may wish to remain present. Tender Form along-with relevant documents has to be purchased from the Gram Panchayat office. Application for Tender paper must be submitted along with all supporting documents in sealed form, noted above NIT NO and SL NO for which sought.

Original certificates or documents as specified in Terms & Conditions (No. 2) must be produced on demand at any stage of tender procedure.

Terms & Conditions :-

1	Cost of Tender Form (non-refundable) has to be paid in cash only.
2	Bidders must submit self attested photocopies of valid GST registration Certificate (if any), last three years income Tax Return (3 Years), Profession Tax Registration Certificate with current challan and Trade Registration Certificate/License from local bodies as the case may be.
3	Contractors must quote rates in absolute numerical values (both in figure and word) and percentage of against the estimate cost.
4	Contractors must submit Credential in similar nature of work.
5	Rate offered by a contractor in a particular Tender shall be treated as final and subsequent negotiation with that contractor for change in price shall not be allowed.
6	Multiple bids (more than one bid by same bidder) and variable rates (different rates of same item by same bidder) shall be rejected outright.
7	No special preferences in respect of earnest money, security Deposit etc. Will be given to any Co-operative Society/ Government owned Company / Government Undertaking / Corporation / Engineering Co-operative etc. In other words, all participating Bidders will be treated of equal basis only and favorable/ Special considerations will be accorded to any bidders.
8	Contractor must submit sealed envelope clearly mentioning serial number and name of work on top of the envelope.
9	Earnest money should be deposited in cash only duly pledged in favour of the Proddhan, Murarai Gram Panchayat and will be refunded. The contractor must collect receipt from Gram Panchayat office. The contractor should furnished the Xerox Copy of the receipt and also quote the number of the receipt in Tender Form.
10	Successful Contractor (s) will be required to lodge security deposit (10% of the total value of the work as quoted by him) as performance security in the form of Cash/Cheque/Bank Draft/Government Bond / Securities duly pledged in favour of the Proddhan, Murarai Gram Panchayat OR the amount may be deducted from every running payment (not exceeding two including the final bill) made and will be released after 3 months in all cases.
11	STDS, TDS and applicable Cess (if any) will be deducted as per existing rates fixed by the respective department of the government. And also all the taxes bears by the successful agency or bidders.
12	Pre-bid conference / meeting with the prospective Bidder will be held on 14/07/2022 at 2.30 P.M (not later than 4 days before the last date of submission of tender) Environmental and social safeguards issues pertaining to tendered work will also be discussed and explained in the meeting.
13	Site visit may be done by the contractors at their own cost.
14	Erroneous or incomplete Tender Form will be summarily rejected without assigning any reason whatsoever.
15	Contractor(s) may be asked to submit rate analysis for items where the quoted rates are either too high or low than the estimated cost. Such bids may also be considered as null and void if there is a reason to believe that the Contractors have formed a cartel and rates have been manipulated, unbalanced or unreasonable.
16	Successful Contractor will have to execute a formal agreement on a Non-Judicial Stamp paper within seven days from the receipt of "Letter of acceptance" with the Gram Panchayat wherein the description, specification, quantity, date of completion of work, other mandatory conditions and ESMF (Environmental and Social Management Framework) issues shall be detailed. Failure to execute the contract will lead to automatic cancellation of the bid.
17	The undersigned is not bound to accept the lowest tender and reserves the right to accept or reject any or all tenders, as the case may be without assigning any reason whatsoever.
18	Quoted rate shall be inclusive of all charges including royalty, transportation etc.
19	Any bid received from the contractor without authentication of correction made in rate quoted in word or figure shall lead to cancellation of the bid.
20	The successful tenderer will have to procure Non-Judicial Stamp paper in his/her own cost.
21	Tender paper will be issued to the qualified contractor. Maximum 03 (three) tender paper will be issued to each applicant. The undersigned is not bound to issue tender paper to all the applicants. Decision of the undersigned regarding issue of the tender paper is final.
22	Audit report of last financial year will have to be submitted in case of Engineers Co-operative and Labour Co-operative Societies. The tender forms are to be received by the chairman or Secretaries or any member of the society having proper power of attorney. In respect of Earnest Money and Security deposit, Cooperative Society / Government owned Company / Government Undertaking / Corporation / Engineering Cooperative etc. will be remained under consideration as per Govt. rules.
