## Eligibility criteria for participating in e-tender:-

2. The bidder shall have satisfactory completed as prime agency during the last 3 years from the date of issue of this notice at least one work of similar type / or as specifically mentioned in the credential column under the authority of State/Central Govt under taking. Statutory bodies constituted under the statute of the Central / State Govt. and having a magnitude of 40 (forty)% of the amount put tender. The completion certificate and details communicational address of the client must be indicated in the credential certificate (Non-Statutory Documents).

3. P. Tax deposit challan for upto date, PAN card, GST Registration Certificate has to be accompanied with the technical Bid document (Non-Statutory Documents). The agency should also have to deposit the IT return certificate for the last three financial year.
