Annexure – B**Terms & Conditions :-**

- Cost of Tender Form (non-refundable) has to paid in cash only.
- Bidders must submit self attested photocopies of valid GST registration Certificate (GST returned Last Month), last three years income Tax Return, Profession Tax Registration Certificate with current challan and Trade Registration Certificate / License from local bodies as the case may be in Current Year.
- Bidders must submit Credential in similar nature of work during last three years.
- In case of bid/tender emanating from cartelization of bidders, entire tender process will be cancelled.
- Bidders must quote rates in absolute numerical values (both in figures and words) and percentage against the estimated cost.
- Rate offered by a bidder in a particular Tender shall be treated as final and subsequent negotiation with the bidder for change price shall not be allowed.
- Multiple bids (more than one bid by same bidder) and variable rates (different rates of same item by same bidder) shall be rejected outright.
- No special preferences in respect of Earnest Money, Security Deposit etc. will be given to any Cooperative Society/Government owned company/Government Undertaking/corporation/Engineering Cooperative in other words, all participating Bidders will be treated on equal basis only and no favourable /special considerations will be accorded to any bidders.
- Bidder must submit sealed envelope clearly mentioning serial number and name of work on top of the envelop.
- Earnest money should be deposited in **Cash only** and the bidder must collect money receipt form Gram Panchayat office and quote the number in tender form.
- Successful Bidder (s) will be required to lodge security deposit (10% of the total value of work as quoted by him) as performance security in the form of Cash/Cheque /Bank Draft duly pledge in favour of the Prodhan, Puranagram Gram Panchayat or the amount may be deducted from every running payment (not exceeding three including the final bill) made and will be released after 6 months in case of Building, Culvert and Concrete Roads and 3 months in all other cases.
- GSTDS, ITDS and Labour cess will be deducted as per existing rates fixed by the respective department of the government.
- Pre-bid conference/meeting with the prospective Bidders will be held on 24.04.2023 At 11.30 A.M. Environmental and Social Safeguards issues pertaining to the tendered work will also be discussed and explained in the meeting.
- Site visit may be done by the bidders at their own cost.


- 5 Erroneous or incomplete Tender form will be summarily rejected without assigning any reason whatsoever.
- 16 Bidder(s) may be asked to submit rate analysis for items where the quoted rates are either below or above 5% that the estimated cost. Such bids may be also be considered as null and void if there is a reason to believe that the Bidders have formed a cartel and rates have been manipulated, unbalanced or unreasonable.
- 17 Successful Bidder will have to executed a formal contract on a Non-Judicial Stamp Paper within seven days from the receipt of "Letter of Acceptance" with the Gram Panchayat wherein de description, specification, quantity, date of completion of work, other mandatory conditions and ESMS (Environmental and Social Management Framework) issues shall be detailed. Failure to execute the contract will lead to automatic Cancellation of the bid.
- 18 The undersigned not bound to accept the lowest tender and reserves the right to accept or reject any or all tenders, as the case may be without assigning any reason whatsoever.
- 19 Quoted rate shall be inclusive of all charges including royalty, GST, tools, charges Transportation etc.
- 20 Any bid received from the bidder without authentication of correction made in rate quoted in word or figure shall lead to cancellation of the bid.
- 21 The successful tenderer will have to procure Non-Judicial Stamp paper in his / her own cost.

Annexure-C

Technical specification for PCC Road

- The whole of the work and materials shall conform to the current edition of relevant Indian standards and PWD(W.B) Schedule of rates (Road & Bridge works 2008-9, 6th, 7th corrigendum).
- The contractor shall keep on site a complete record with if any changes, such records shall be made available for inspection by the engineer during executing the work.
- The contractor will be responsible for any claims arising from damage to services or to adjacent structures or property, at the time of executing the work.
- The contractor responsibility to protect existing structures and utilities from damage or interruption of services due to excavation work
5. The contractor shall provide a skilled person for supervision of all construction work accordance with the drawing and specification.
- The compaction of sub grade shall be performed with suitable compacting equipment such power roller or vibrating roller if necessary approved by the engineer.
- Surface finishing should be smooth, Plate vibrator must be used for Rigid Pavement casting, small surface holes caused by air bubbles, normal form joint marks, and minor chips and spalls will be tolerated, but no major unsightly imperfections, honeycomb or structural defects will be permitted.
- Cement shall be Portland & specified used as soon as possible after delivery, any cement that has been stored for a period accessing Three (3) months shall not be used until it has been tested for suitability.
- Fine aggregate (Sand) shall be clean sharp, coarse & well graded free from soft particle, clay, shell or any other deleterious materials.
- Coarse aggregate (jelly or stone) the combined coarse aggregate shall be suitable for making a dense concrete of appropriate workability with the proportions of cement and water with which the aggregate is to be used also the aggregate shall be well graded and free from dust, dirt & nuisance.
- Bricks shall be locally available or equivalent and be hard, well baked and shall have an uniform and sufficient compressive strength and the shape shall be rectangular.
- Mixing water shall be clean and free from oil, acids, alkalis, salt, organic material or substance which may deleterious to concrete.
- All the concrete shall be machine mixed & the concrete mixer shall be clean at all times.
- The concrete shall be placed in its final position as soon as possible and in any case not later than half an hour after mixing.
- The concrete shall be transported from the mixer to the position of placing in such a manner that segregation of the mix shall not occur.
- Suitable side drains should be provided to prevent stagnation of water and it should be connected with suitable out falls for the disposal.
- Not be permitted to walk over freshly placed concrete until it has hardened sufficiently to carry their weight without distortion, also to Barricade the road from both of the end till initial setting of the concrete.
- The Form work must be uniform in length & be removed after 12 hours of completion of casting.
- Expansion joints shall be provided at an interval of 10mtr apart and it should be perpendicular to cross section of road.
- Camber shall be provided maximum 2.5% for Rigid Pavement.
- Following the curing period, keep wet continuously for not less than seven(7) days after being removed from the forms.

According to order vide no. 594/ISGPP/20E-2(Proc)/39 the Gram panchayats are allowed to utilize 0.5% of estimated value of a scheme out of block grant of ISGPP Project for meeting unforeseen expenditure(Contingency) and for monitoring and supervision of schemes


