- 4.In case of bid /tender emanating from cartelization of bidders, entire tender process will be cancelled.
- 5. Bidders must quote rates in absolute numerical values (both in figures and words) and percentage against the estimated
- 6.Rate offered by a bidder in a particular Tender shall be treated as final and subsequent negotiation with that bidder for
- 7. Multiple bids (more than one bid by same bidder) and variable rates (different rates of same itemby same bidder) shall be
