VI. The material should conform strictly to the P.W.D. specification and quantity of work as indicated above is provisionally final. The Gram Panchayat reserves the right to reduce or increase the quantity of work or taken up any part of work for execution departmentally for which no compensation is payable to the supplier at any circumstances.

VII. For unexecuted work within the stipulated period the supplier / tenderer may be asked to pay a penalty ranging from 1% to 2% for every fortnight.

VIII. The work shall commence within one week from the issue of the work order and will be carried out under the supervision of the Nirman Sahayak/SIP concerned. Prior to the Commencement of the work the supplier / tenderer must inform the office communicating the date of commencement of work to this office and the Job Assistant / Nirman Sahayak/SIP Concerned.
