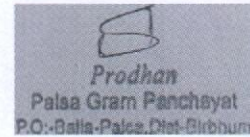

Without uploading the scanned copy of EMD in form of demand draft/Cash, the tenders will be treated as non-responsive.

6. The undersigned reserves the right to reject any or all tenders without assigning any reason what so ever.



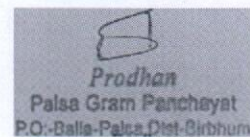
