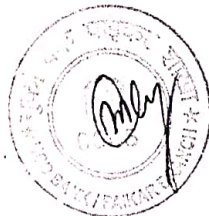

- i) Application for tender paper should be submitted to the undersigned during office hours along with photo - copy of valid PAN card , Upto Date Income Tax, P. tax, Trade License, Vat Registration / G.S.T. and Credential up to Three Years (in the form of Payment certificate and completion certificate of a single work) of the Engineer-in-charge must be submitted in original and photocopy.
- 2) **Earnest money deposited by D.D. / cash Only, deposit in Paikar-I G.P.**
- 3) In case of running work order and up-to-date payment certificate of the Engineers-in-charge must be produced as above.
- 4) Tender papers will be issued to the qualified contractors. The undersigned is not bound to issue tender paper to all the applicants. Decision of the undersigned regarding issue to tender paper is final.
- 5) Tender paper will have to send by hand and it should reach to the undersigned within schedule date & time. Tender Paper received after tenderers may remain present at the time of opening of the Tender.
- 6) If any work found defective during work or Security period the same is to be rectified by the Contractor at his own cost.
- 7) Casting works will not be executed on Sunday/Holiday and at night. All casting work will be done in presence of Nirman Sahayak, Paikar-I GP.
- 8) Extension of time for completion of the work will not be allowed in normal circumstances. If any contractor fails to complete the work within schedule time, all his bills including earnest money, security money will be forfeited.
- 9) Necessary deductions due to voids and shrinkage will be made. Necessary deductions of taxes from the bill will be made as per existing Govt. rules.
- 10) No materials will be supplied by the undersigned.
- 11) No extra payment due to theft, damage etc. will be entertained.
- 12) All other terms and condition as per PWD rules will be followed.
- 13) The materials shall be of the best description and in strict accordance with the specification .The contractor shall receive payment for such materials only as are approved and passed by the Nirman Sahayak.
- 14) The volume of the work may increase/decrease and payment will be made as per accepted rate.
- 15) The decision of the Ortho-O-Parikalpana Upasmitry of the Paikar-I Gram Panchayat shall be final, binding and conclusive on all questions.
- 16) Signature in the tender document should be in all pages and all signatures must be dated.
- 17) The work shall be carried out strictly according to the Schedule of the work, technical specifications and drawings.
- 18) All provisions of labour law including any amendment shall be followed strictly of the Minimum Agency. No child labour shall be engaged. Proper working condition for the labour shall be wages Act. Local labours shall be engaged and minimum wages shall be paid to them accordingly.

- 19) The Agency shall remove all the unserviceable materials from the site after completion of the work including temporary sheds, vats & rubbishes etc. and shall dress & level the work site at his own cost as per direction of the Nirman Sahayak, Paikar-I GP.
- 20) Canvassing in connection with the tender process shall be strictly prohibited.
- 21) If the contractor or his work people break or deface any building/road/fence/enclosure/grass land/cultivated land he shall repair/make good the same at his own expense, and in the event of his refusing or failing to do so the damages shall be repaired at his expense the Prodhan, Paikar-I GP who shall deduct the cost from any sums due or which may become due to the contractor.
- 22) The contract shall not be sub-let without prior written permission from the authority concerned. In the event of the contractor sub-letting his contract without such permission, he shall be considered to have thereby committed a breach of contract, and his security deposit shall be forfeited and shall have no claim for any compensation for any loss that may accrue from the material he may have collected or engagement entered into.
