2 The scanned copy of NEFT/RTGS Bank Challan for both cost of tender document and EMD must be uploaded with technical bid, otherwise bid will be clearly jected. Both Technical Bid & Financial Bid will have to be submitted concurrently dully digitally signed in the P&RD website [wbenders.gov.in](http://wbenders.gov.in). Tender documents may be downloaded from website & submission of technical bid/financial bid will be done as per tender schedule stated in Sl. No. 9. The documents submitted.

3 **Eligibility criteria for participation in tender:-**

a) The prospective bidders shall have **satisfactorily completed as primary agency same nature of work**, in consolidated form or equal to at least 60% (sixty) value for Tender value upto 5 Lakh, 50% (fifty) value for Tender value upto 5 to 10 Lakh and 40% (forty) value for Tender value above 10 Lakh, which bid is invited during the last 3(three) years prior to the date of issue of this notice under Zilla Parishad, P.W.D., C.P.W.D., & similar other Govt. Department.

b) Pan Card, Current Professional Tax Certificate with Receipt Challan, IGST Registration Certificate, Current GST return, Trade License, Current Income Tax acknowledge Receipt Last Three Years. (Non-Statutory Documents).

c) Neither prospective bidders nor any of constituent partners had been debarred to participation in tender by any Govt. Department during the last 5(five) years prior to the date of this e-NIT. Such tender will be considered as disqualification towards eligibility.

d) Registered Unemployed Engineers' Co-Operative Society / Unemployed Labour Co-Operative Societies are required to furnish Valid Bye-Law, Valid Register Certificate issued by the Co-Operative Deptt. Current Audit Report, Annual General Meeting along with other relevant supporting papers. (Non Statutory Documents)

e) A prospective bidder shall be allowed to participate in the job either in the capacity of individual or as a partner of a firm. If found to have applied severally in a single job, all his applications will be rejected for the job only

f) A prospective bidder (including his participation in partnership) shall be allowed to participate maximum two works as mentioned in the list of schemes.

N.B. – Original certificates or documents as specified in Annexure-B (No. 2 & 3) must be produced on demand at any stage of tender procedure.

#### Terms & Conditions :-

- Cost of Tender Form (non-refundable) has to paid in cash only.
- Bidders must submit self attested photocopies of valid GST registration Certificate (GST returned Last Month), last three years income Tax Return, Profession Tax Registration Certificate with current challan and Trade Registration Certificate / License from local bodies as the case may be in Current**
- Bidders must submit Credential in similar nature of work during last three years.**
- In case of bid/tender emanating from cartelization of bidders, entire tender process will be cancelled.
- Rate offered by a bidder in a particular Tender shall be treated as final and subsequent negotiation with the bidder for change price shall not be allowed.
- Multiple bids (more than one bid by same bidder) and variable rates (different rates of same item by same bidder) shall be rejected outright.
- No special preferences in respect of Earnest Money, Security Deposit etc. will be given to any Cooperative Society/Government owned company/Government Undertaking/corporation/Engineering Cooperative in other words, all participating Bidders will be treated on equal basis only and no favourable /special considerations will be accorded to any bidders.
- GSTDS, ITDS and Labour cess and security deposit (10% of the total value of work will be deducted as per existing rates fixed by the respective department of the government.
- Security deposit will be released after 6 months in case of Building, Culvert and Concrete Roads and 3 months in all other cases.
- Environmental and Social Safeguards issues pertaining to the tendered work will also be maintainer by the bidder.
- Site visit may be done by the bidders at their own cost.
- Erroneous or incomplete Tender form will be summarily rejected without assigning any reason whatsoever.
- Bidder(s) may be asked to submit rate analysis for items where the quoted rates are either below or above 5% that the estimated cost. Such bids may be also be considered as null and void if there is a reason to believe that the Bidders have formed a cartel and rates have been manipulated, unbalanced or unreasonable.
- Successful Bidder will have to executed a formal contract on a Non-Judicial Stamp Paper within seven days from the receipt of "Letter of Acceptance" with the Gram Panchayat wherein de description, specification, quantity, date of completion of work, other mandatory conditions and ESMF (Environmental and Social Management Framework) issues shall be detailed. Failure to execute the contract will lead to automatic Cancellation of the bid.
- The undersigned not bound to accept the lowest tender and reserves the right to accept or reject any or all tenders, as the case may be without assigning any reason whatsoever.
- Quoted rate shall be inclusive of all charges including royalty, GST, tools, charges Transportation etc.
- Any bid received from the bidder without authentication of correction made in rate quoted in word or figure shall lead to cancellation of the bid.
- The successful tenderer will have to procure Non-Judicial Stamp paper in his / her own cost.

Annexure-C

Technical specification for Building(SSK, kitchen shed, Publictoilet, swasanchulli, passenger shed etc)

- 1 The whole of the work and materials shall conform to the current edition of relevant Indian standards and PWD(W.B) Schedule of rates 2017(Building works materials and labour).
- 2 The contractor shall keep on site a complete record with if any changes, such records shall be made available for inspection by the engineer during executing the work.
- 3 The contractor will be responsible for any claims arising from damage to services or to adjacent structures or property, at the time of executing the work.
- 4 The contractor responsibility to protect existing structures and utilities from damage or interruption of services due to excavation work.
- 5 Excavation shall not be backfilled until such structures and properties as drainage, insulation pipes, construction details, and water tightness have been inspected, tested and approved by the engineer.
- 6 The contractor shall provide a skilled person for supervision of all construction work accordance with the drawing and specification.
- 7 Reinforcing bar should be deformed bars for all Reinforced Cement Concrete (RCC) work, and should have Thermo Mechanically Treated (TMT) and minimum yielding strength of 414 n/mm<sup>2</sup>.
- 8 Cement shall be Portland & specified used as soon as possible after delivery, any cement that has been stored for a period accessing 3 months shall not be used until it has been tested for suitability.
- 9 Fine aggregate (Sand) shall be clean sharp, coarse & well graded free from soft particle, clay, shell or any other deleterious materials.
- 10 Coarse aggregate (jelly or stone) the combined coarse aggregate shall be suitable for making a dense concrete of appropriate workability with the proportions of cement and water with which the aggregate is to be used also the aggregate shall be well graded and free from dust, dirt & nuisance.
- 11 Bricks shall be locally available or equivalent and be hard, well baked and shall have an uniform and sufficient compressive strength and the shape shall be rectangular.
- 12 Mixing water shall be clean and free from oil, acids, alkalis, salt, organic material or substance which may deleterious to concrete or reinforcement.
- 13 All the concrete shall be machine mixed & the concrete mixer shall be clean at all times.
- 14 The concrete shall be placed in its final position as soon as possible and in any case not later than half an hour after mixing.
- 15 The concrete shall be transported from the mixer to the position of placing in such a manner that segregation of the mix shall not occur.
- 16 Surface finishing should be smooth, nozzle vibrator must be used for RCC & PCC work, small surface holes caused by air bubbles, normal form joint marks, and minor chips and spalls will be tolerated, but no major unsightly imperfections, honeycomb or structural defects will be permitted.
- 17 Spacing block shall be used to insure accurate cover to the reinforcement, where necessary, and these blocks shall precast concrete they shall be as small as possible.
- 18 Following the curing period, keep wet continuously for not less than seven(7) days after being removed from the forms.
- 19 According to order vide no. 594/ISGPP/20E-2(Proc)/39 the Gram panchayats are allowed to utilize 0.5% of estimated value of a scheme out of block grant of ISGPP Project for meeting unforeseen expenditure(Contingency) and for monitoring and supervision of schemes.
- 20 Camber shall be provided maximum 2.5% for Rigid Pavement.
- 21 Following the curing period, keep wet continuously for not less than seven(7) days after being removed from the forms.
