SELF DECLARATION MUST BE SUBMITTED REGARDING RULE-17

- 1. Cost of Tender paper (non-refundable) has to be paid in cash only.
- 2. Contractors must submit self attested photocopies of
 - a) valid GST registration Certificate.
 - b) PAN with last three years Income Tax Return.
 - c) Professional Tax Registration Certificate with current challan.
 - d) Trade Registration Certificate/License from local bodies as the case may be.
- 3. Bidders must submit credential (same work) in similar nature of work. As per Annexure- C.
- 4. In case of bid/tender emanating from cartelization of contractors, entire tender process will be cancelled.
- Contractors must quote rates in absolute numerical values (both in figures and words) against the estimated cost. Rate quoted in percentage term will not be allowed.
- 6. Rate offered by a contractor in a particular Tender shall be treated as final and subsequent negotiation with that contractor for change in price shall not be allowed.
- 7. Multiple bids (more than one bid by same contractor) and variable rates (different rates of same item by same contractor) shall be rejected outright.
