- 4). All duties, taxes, royalties, cess, toll, taxes and other levies payable by the Contractor under the Contract to the state / Central Government for any other cause, shall be included in the rates prices and total Bid price submitted by the bidder.
- 5). In case of Electrical works the agency should have personnel having Electrical Contractors License & Supervisory License of respective category.
