NOTICE INVITING TENDER

Sealed tenders are hereby invited from the bonafide, resourceful contractors/ agencies of Birbhum Zilla Parishad having valid trade licence and all types of tax clearance certificate for the following works (List of work attached) to be under taken by the Panchayat Samiti.

Quantity of any item(s) may vary 20% for which no change of rate will be allowed. Application for tender along with GST, Income Tax, Profession Tax clearance will be received upto 2.00 pm on 04/07/2022. 40 % Credential of similar nature of work with payment certificate and work order of last three Financial Year must be submitted with application . Selected applicant must have to receive tender papers for which he/she has applied for. Defaulter agency or contractor may not be issued tender paper and the decision of the Panchayat Samiti will final & binding.

Permission will be given to tenderers on 05/06/2022 at 2.30 pm and tender papers and other documents will be issued on 06/07/2022 from 11.00am upto 4.00 pm. Tenderers are requested to quote the rates on percentage basis (In word & Figure mentioning clearly Above / At Par / Below of schedule rate) and that will be received on 08/07/2022 upto 2.00 pm and will be opened on the same date after 2.30 pm in presence of the intending tenderers. 2% (Two Percent) of the tender amount shall have to be deposited as *earnest money* by bank draft only in favour of "Executive Officer, Sainthia Panchayat Samiti" by all tenderers including Co-operative Societies formed by unemployed Engineers and Diploma holders. Bank receipt slip regarding earnest money will not be entertained, and such tender forms will be summarily rejected. Co-operative Societies / Labour Co-operative Societies are directed to submit Working Certificate for the current financial year issued by the competent authority.


Tenderers shall have to write their name and address, serial no. & name of the work with NIT memo no. on the envelopes containing the tender papers otherwise the envelopes may not be opened at all. Tender papers without requisite papers and earnest money will be summarily rejected.

After receipt of respective schedule rates of works tenderers should inspect the site and acquaint themselves with difficulties and peculiarities, if any prevailing at site and quote the rate accordingly. The authority reserves the right to accept or reject any or all of the tenders and/ or may get completed any part of work by the engaged contractors/ agencies without assigning any reason thereof. Work order will be issued only after getting sanction letter and/ or receipt of fund for this purpose.

N.B.

- (1) Every document should be self attested properly.
- (2) All materials like steel, cement, bricks, etc. will have to be procured by the contractor from authorised dealer and should be approved by authority. Different size of stone chips (pure) should be supplied seperately.
- (3) No any difference of cost of any material shall be entertained anyway.
- (4) Royalty, Cess, etc. shall have to be paid by the contractor as per Rule.
- (5) Work should be started within 7 (Seven) days from date of receipt of Work Order and should be submitted a tentative work schedule positively in consultation with cencereend SAE and if any difficulties to start the work should be intimated in due time to the undersigned.
- (6) Payment of R.A Bill is not the right of the Agency or Contractor, only final bill will be entertained . R.A Bill may be entertained , if situation demands.


