# **Technical specification for Culvert & Drain**

- The whole of the work and materials shall conform to the current edition of relevant Indian standards and PWD(W.B) Schedule of rates (Road & Bridge works 2008-9.6th.
- The contractor shall keep on site a complete record with if any changes, such records shall be made available for inspection by the engineer during executing the work.
- 3 The contractor will be responsible for any claims arising from damage to services or to adjacent structures or property, at the time of executing the work.
- The contractor responsibility to protect existing structures and utilities from damage or interruption of services due to excavation work
- The contractor shall provide a skilled person for supervision of all construction work accordance with the drawing and specification.
- Reinforcing bar should be deformed bars for all Reinforced Cement Concrete (RCC) work, and should have Thermo Mechanically Treated (TMT) and minimum yielding strength of 414 n/mm2.



- 7 Cement shall be Portland & specified used as soon as possible after delivery, any cement that has been stored for a period accessing 3 months shall not be used until it has been tested for suitability.
- 8 Fine aggregate (Sand) shall be clean sharp, coarse & well graded free from soft particle, clay, shell or any other deleterious materials.
- 9 Coarse aggregate (jelly or stone) the combined coarse aggregate shall be suitable for making a dense concrete of appropriate workability with the proportions of cement and water with which the aggregate is to be used also the aggregate shall be well graded and free from dust, dirt & nuisance.
- 10 Bricks shall be locally available or equivalent and be hard, well baked and shall have an uniform and sufficient compressive strength and the shape shall be rectangular.
- 11 Mixing water shall be clean and free from oil, acids, alkalis, salt, organic material or substance which may deleterious to concrete or reinforcement.
- 12 All the concrete shall be machine mixed & the concrete mixer shall be clean at all times.
- 13 The concrete shall be placed in its final position as soon as possible and in any case not later than half an hour after mixing.
- 14 The concrete shall be transported from the mixer to the position of placing in such a manner that segregation of the mix shall not occur.
- Surface finishing should be smooth, nozzle vibrator must be used for RCC & PCC work, small surface holes caused by air bubbles, normal form joint marks, and minor chips and spalls will be tolerated, but no major unsightly imperfections, honeycomb or structural defects will be permitted.
- 16 Spacing block shall be used to insure accurate cover to the reinforcement, where necessary, and these blocks shall precast concrete they shall be as small as possible.
- 17 Following the curing period, keep wet continuously for not less than seven(7) days after being removed from the forms.
- According to entervide no. 584/ISGPP/20E-2(Proc)/39 the Gram panchayats are allowed to utilize 0.5% of estimated value of a scheme out of block grant of ISGPP Project for meeting unforesten expenditure(Contingency) and for monitoring and supervision of schemes.
- 19 Ensure proper design including slope, cross-section, lining etc, to avoid silt accumulation, backflow etc.
- 20 Ensure that drain is only for sullage and effluent from septic tank, etc., does not flow into it., periodic cleaning and silt removal from the drain.
- 21 Following the curing period, keep wet continuously for not less than seven(7) days after being removed from the forms.
