The bidders are requested also to visit the web page of the tender since the starting date of downloading documents so as they may submit the documents as sought for by the authority of this Gram Panchayat .
4	Only lowest bidder deposit the Earnest Money Deposit(i.e. Demand Draft) to the Secretary of Parulia Gram Panchayat as mentioend agaisnt each work at the time of signing agreement. All duties, taxes, royalties , cess, toll taxes and other levis payable by the contractor under the contract to the State/ Central Government for any other cause, shall be included in the rates prices and total Bid Price submitted by the bidder.
6	The undersinged reserves the right to reject any or all tenders without assigning any reason what so ever at any stage.
7	All works will be have to be done according to specification and drawing approved by the authority and as per direction of the concerend N.S. of this Panchayat.
