Time is the essence of contract. The successful Tenderer must complete the work within the time specified for completion. **No extension of time will be allowed except in special case.** If any Agency fails to complete the work within stipulated time, the Work order /Supply order issued in his favor will be cancelled without assigning any reason thereof. The undersigned may also proceed to get the balance work completed by any other means including through other Agency. The excess expenditure, if any, due to such a step would be recoverable from the unpaid bills/Earnest money deposit /security deposit of the Tenderer. **As per rule; Clause (2) will be applied to the defaulting Agency.**

1. The authority shall straightway reject the price-bids which may appear to be absurd in terms of rates and with the mala-fide intention of competition only.
