The bidders are requested also to visit the web page of the tender since the starting date of downloading documents so as they may submit the documents as sought for by the authority of this Panchayat .
4	All duties, taxes, royalties, cess, toll taxes and other levies payable by the contractor under the contract to the State/ Central Government for any other cause, shall be included in the rates prices and total Bid Price submitted by the bidder.
5	The undersigned reserves the right to reject any or all tenders without assigning any reason what so ever at any stage.
6	All works will have to be done according to specification and drawing approved by the authority and as per direction of the concerned officer of this Panchayat.
7	Before submission of tender, the contractor may visit the work site to judge the local condition from all corners and no Complain about the site will be entertained afterwards. It will assumed that the agency offered the tender rate only after reviewing entire position of the particular work site.
