- The Firm/Contractor/Agency must submit his/her/their self-attested photocopies of (a) Latest Professional Tax payment certificate (b) PAN Card (c) Income Tax Return for last Three years (AY- 2022-2023, AY- 2021-2022 and

AY- 2020-2021) (d) GST Registration Certificate (e) Credential Certificate (including Work Order, Payment Certificate and Completion Certificate) (f) Valid Engineers and Labour Co-operative Society Registration (if applicable) (g) Trade License. (h) In addition, the Firm/Contractor/Agency should submit an affidavit (on non-judicial stamp paper of Rs.10/-), by declaring that the documents submitted with application are true of his/her/their best of knowledge and this affidavit should be sworn in with Notary Public positively.

4. The rate tendered (both in figure and words) by Firm/Contractor/Agency shall be complete in all respect and including all incidental charges also inclusive of taxes etc. as applicable but excluding GST and Labour Welfare Cess.

5. Time is the essence of contract, if the Firm/Contractor/Agency fails to follow the limit of completion period strictly for executing allotted work the Tendering Authority reserves all rights to allot the work to the other Firm/Contractor/Agency in the sequence of suitability as per comparative statement and forfeit the security money and/or EMD and may impose penalty valuing upto 10% of the tender amount or any other action as per provision of the Government rules & laws as applicable.

6. Last date of application for Permission is on 14/09/2022 upto 4:00 P.M. Last Date of purchase of Tender Paper is on 15/09/2022 upto 4:00 P.M.

7. The sealed Tender Paper duly filled in must be dropped in the Tender Box situated in the room of the Dealing Assistant of the undersigned on or before 16/09/2022 upto 2:00 P.M. and Name of the work, NIT No. and Name & Address of the Firm/Contractor/Agency shall be super scribed on the envelope containing the Tender Paper. The Tenders will be subsequently opened on the same day afterwards 2:30 P.M.

8. Cost of Tender Paper is to be submitted in cash to the Cashier of Office of the Rampurhat – II Panchayat Samiti and the photocopy of DCR (Duplicate Carbon Receipt) of the payment so made shall be attached alongwith the application for permission.

9. All tenderers are requested to remain present at the time of opening of tender papers, otherwise any objection regarding process of tendering will stand cancelled prima-facia.

10. The certificate stating, “**all equipments related to the works shall be supplied by constructing agency**” should be given on the body of the tender paper by the tendered.

11. The Firm/Contractor/Agency before tendering rates shall visit the proposed site of work and have knowledge of the site conditions.

12. If tendered rate is lesser than 15% of the scheduled rate of works put to tender, then he/she/they has/have to submit the rate analysis along with the tender paper within the same sealed envelope at the time of dropping tender.

13. Tender amount and schedule of quantities may vary to any extent for which no claim is admissible to the tendering Firm/Contractor/Agency and no claim is admissible also for price escalation.

14. The Defect-Liability period for all of tabulated work(s) other than Electrical Street Light Installation is/are 01 (One) year counted from the date of completion of the work. The Defect-Liability period for Installation of Electrical Street Light work(s) is/are 02 (Two) years counted from the date of completion of the work.
