No scan copy of EMD will be accepted (Ref No. 3975-F9Y) dated 28th July 2016 of Finance Department, Govt. of West Bengal.

3. The tenderer will have to submit their bid on-line in two cover/folder system containing pre-qualification document (Technical Bid in one and Financial Bid in another). The list of important dates is also given in Section-I of Standard Bidding Document (SBD).

4. The Firm/Contractor/Agency must upload scanned copies of his/her/their self-attested photocopies of (a) Latest Professional Tax payment certificate (b) PAN Card (c) Income Tax Return for last Three years (AY- 2022-2023, AY- 2021-2022 and AY- 2020-2021) (d) GST Registration Certificate (e) Credential Documents (Comprising of Work Order, Payment Certificate and Completion Certificate of the same work) (f) Valid Engineers and Labour Co-operative Society Registration (if applicable) (g) Uptodated Trade License. (h) In addition, the Firm/Contractor/Agency should submit an affidavit (on non-judicial stamp paper of Rs.10/-) in sample format as per S.B.D. Annexure-, by declaring that the documents submitted with application are true of his/her/their best of knowledge and this affidavit should be sworn in with Notary Public positively.

6. Time is the essence of contract, if the Firm/Contractor/Agency fails to follow the limit of completion period strictly for executing allotted work the Tendering Authority reserves all rights to allot the work to the other Firm/Contractor/Agency in the sequence of suitability as per comparative statement and forfeit the security money and/or EMD and may impose penalty valuing upto 10% of the tender amount or any other action as per provision of the Government rules & laws as applicable.
7. The date of downloading Pre-qualification cum Tender Document starts on 29/09/2022 at 4:30 P.M. Online bid submission starts on 29/09/2022 at 5:00 P.M.
8. The online bid submission must be done on or before 11/10/2022 upto 5:00 P.M. The Technical Bids will be opened on 14/10/2022 at 11:00 A.M. Financial Bids of the tenderers qualified in Technical Bids be subsequently opened on 19/10/2022 at 2:00 P.M.
9. All tenderers are requested to remain present at the time of opening of tender papers, otherwise any objection regarding process of tendering will stand cancelled prima-facia.
10. The Firm/Contractor/Agency before tendering rates shall visit the proposed site of work and have knowledge of the site conditions.
11. If tendered quotation of rate is lesser than 15% of the scheduled rate of works put to tender, then he/she has to submit the rate analysis sealed envelope as and when asked for the same in the office of the undersigned.
12. Tender amount and schedule of quantities may vary to any extent for which no claim is admissible to the tendering Firm/Contractor/Agency and no claim is admissible also for price escalation.

14. All materials, fittings, fixtures and equipment to be used for the above tabulated works are to be conformed with relevant Bureau of Indian Standards and other relevant Engineering Standards as applicable.
15. The Authority inviting quotations reserves all rights to cancel/reject any or all tenders without assigning any reasons whatsoever.
16. Work Order for the above work to the qualified and selected bidders as per tender to whom the work will be awarded shall only given if/ when the required fund for the said work will be available at this end.
17. The Defect-Liability period for all of tabulated work(s) other than Electrical Street Light Installation is/are 01 (One) year counted from the date of completion of the work. The Defect-Liability period for Installation of Electrical Street Light work(s) is/are 02 (Two) years counted from the date of completion of the work.

18. Any Tenderer under whatsoever ground requests/pray for his/her/their withdrawal of tender at any stage of tendering process shall be treated as an attempt to hinder the tendering process and wasting Government's Time and shall be liable to his/her/their EMD to be forfeited and/or to be debarred from participating in any other tender(s)/quotation(s) for all service(s)/work(s) under Rampurhat – II Panchayat Samiti and Rampurhat – II Development Block for 01 (One) Year from the date of such written order/notice in addition to any other penalizing measure(s) as decided by the tendering authority.

19. A Tenderer is allowed to participate upto only 05 (Five) Nos. of works/services as mentioned in the above table and serial as mentioned in the above list of work(s)/service(s) under this e-NIT. If applied in more than 05 numbers of work(s)/service(s) then participation in First Five in the ascending order of serial of work(s)/service(s) shall only be considered and remaining shall stand as invalid.

20. Additional Performance Security @10% of the tendered amount will be obtained from the successful bidder if the accepted bid value is 80% or less the Amount Put to Tender. The Additional Performance Security shall be taken in the form of Bank Guarantee from any Scheduled Bank before issuance of the Work Order.

21. In addition to the above clauses, terms/conditions/statements/clauses as mentioned in the SBD (Standard Bidding Document) uploaded for this e-NIT by the tendering authority shall be applicable to the contract between the Agency and the Tendering Authority until the completion of the Defect-Liability Period as applicable for the concerned work. In case of any contradiction of terms/conditions/statements/clauses between as mentioned in this e-NIT and the said SBD, this e-NIT shall be followed.
