Annexure-A

Terms & Conditions :-

1. Cost of Tender Form (non-refundable) has to be paid in cash only .
2. Bidders must submit self attested photocopies of valid GST registration Certificate, Income Tax Return, Profession Tax Registration Certificate, Pan Card, Payment Certificate and Trade Registration Certificate/License from local bodies as the case may be.
3. **Bidders must submit Credential in similar nature of work during last three years.**
4. Bidders must quote rates in absolute numerical values (both in figures and words) and percentage against the tender
5. Rate offered by a bidder in a particular Tender shall be treated as final and subsequent negotiation with that bidder for change in price shall not be allowed.
6. Multiple bids (more than one bid by same bidder) and variable rates (different rates of same item by same bidder)for same work shall be rejected outright.
7. No special preferences in respect of Earnest Money, Security Deposit etc. will be given to any Co-operative Society/Government owned Company/Government Undertaking/Corporation/ Engineering Cooperative etc. In other words, all participating Bidders will be treated on equal basis only and no favourable/special considerations will be accorded to any

- bidder must submit sealed envelope clearly mentioning serial number and name of work on top of the envelop.
- the bidder must collect receipt from Gram Panchayat office and will be refunded/forfeited as the case may be.
10. 10% Of the bill amount will be kept in this office as security deposite for six month from the date of completion of work.
11. GST, ITDS and Labour Cess will be deducted as per existing rates fixed by the respective department of the government.
12. Erroneous or incomplete Tender Form will be summarily rejected without assigning any reason whatsoever.
13. Bidder(s) may be asked to submit rate analysis for items where the quoted rates are either below or above 5% than the estimated cost. Such bids may also be considered as null and void if there is a reason to believe that the Bidders have formed a cartel and rates have been manipulated, unbalanced or unreasonable.
14. Successful Bidder will have to execute a formal contract on a Non-Judicial Stamp paper within seven days from the receipt of "Letter of Acceptance" with the Gram Panchayat wherein the description, specification, quantity, date of completion of work, other mandatory conditions and ESMF (Environmental and Social Management Framework) issues shall be detailed. Failure to execute the contract will lead to automatic cancellation of the bid.
15. The undersigned is not bound to accept the lowest tender and reserves the right to accept or reject any or all tenders, as the case may be without assigning any reason whatsoever.
16. Quoted rate shall be inclusive of all charges including Royalty, GST, Tools charges, Transportation etc.
17. Any bid received from the bidder without authentication of correction made in rate quoted in word or figure shall lead to cancellation of the bid.
18. Bidders will get necessary drawings with the Tender Form. All documents i.e. drawings Tender Form & Tender Document signed by the Bidder must be submitted in Sealed Tender addressed to Pradhan, Bara-II Gram Panchayat, Vill - Bhabanipur, PO-Jestha, PS-Nalhati, District- Birbhum.
19. Time is the essence of contract. The successful Contractor must Complete the work at site the time specified for completion. No extension of time will be allowed except in special case. If any Contractor fails to do the Work within the stipulated time the Work order issued in his favour will be cancelled & forfeited his Earnest Money without assigning any reason therefore. And the same Work order issue to the 2nd Lowest Agency.
20. Payment should be made as per availability of funds.
21. The authority to reserves the right to accept or to reject cr all tenders without assigning any reason.
22. Before submission of tender, Contractor must visit/ Inspect the work site at his own cost to judge the local situation/Condition. No plea /Complain Shall be entertained afterwards.
23. The successful tenderer will have to procure Non-Judicial Stamp paper in his/her own cost.
24. Any Contractor/ Supplier is allowed to issue paper for four Nos of the work.
26. Submit work completion certificate which will issue to Succesful contractor from Gram panchayat at the time of Work order recived at the same time agency bound to submit 3 stage hard copy photo graph of concerned work with materials testing report.


