

2	Income Tax return should be uploaded for the last 3 (three) year with the Technical Bid.
3	Photo copy of Professional Tax Deposit Chalan along with enrollment Certificate, GST registration Certificate & PAN Card should be uploaded. The bidders are requested also to visit the web page of the tender since the starting date of downloading documents so as they may submit the documents as sought for by the authority of this Panchayat Samiti.
4	Only lowest bidder deposit the Earnest Money Deposit( i.e. Demand Draft) to the Cashier of Sainthia Panchayat Samiti as mentioned against each work at the time of signing agreement.
