- 3) Self attested Scanned copy of Professional Tax (P.Tax) deposit receipt/current challan for the financial year 2022-23, last three years Income Tax return, PAN Card, the GSTN Registration Certificate, voter id card and adhar card.

- 4) Bidders must submit attested photocopies of valid **15 – digit Goods and Services Taxpayer Identification Number (GSTIN) under GST Act, 2017**, last three years Income Tax Return, xerox copy of voter card, xerox copy of adhar card, Profession Tax Registration Certificate with current challan and Trade Registration Certificate/License from local bodies as the case may be.
- 5) Bidders must submit Credential and Completion Certificate in similar nature of work during last three years
- 6) In case of bid/tender emanating from cartelization of bidders, entire tender process will be cancelled.
- 7) Bidders must quote rates in percentage and absolute numerical values (both in figures and words) against the estimated cost.
- 8) Rate offered by a bidder in a particular Tender shall be treated as final and subsequent negotiation with that bidder for change in price shall not be allowed
- 9) Multiple bids (more than one bid by same bidder) and variable rates (different rates of same item by same bidder) shall be rejected outright.
- 10) No special preferences in respect of Earnest Money, Security Deposit etc. will be given to any Cooperative Society/Government owned Company/Government Undertaking/Corporation/ Engineering Cooperative etc. In other words, all participating Bidders will be treated on equal basis only and no favourable/special considerations will be accorded to any bidders.
- 11) In case of same rate bid by different bidder for a single work, higher credential will be considered.

- 12) For maturity of technical bid minimum 3(three) bid will be required for a single work/contract, if not so financial bid will not be opened and 2nd call will be took place for the same eNIT and previuos bidder will autometically eligible and not necessary to submit further documents or bid.
- 13) Successful Bidder (s) will be required to lodge security deposit (10% of the total value of the work as quoted by him) as performance security in the form of Cash/Cheque/Bank Draft/Government Bond / Securities duly pledged in favour of the Pradhan, Bara Saota Gram Panchayat or the amount may be deducted from every running payment (not exceeding three including the inal bill) made and will be released 6 months in case of Building, Culvert and Concrete Roads and 3 months in all other cases.
- 14) GST, ITDS and Labour Cess will be deducted as per existing rates fixed by the respective department of the government.
- 15) The successful bidder must obey the Environmental and Social Safeguards issues pertaining to the tendered work.
- 16) The bidder is advised to visit and examine the Site of Works and its surroundings and obtain all information and data for preparing the bid. The cost of visiting the site and collection of information and data shall be at the bidder's own expenses.
- 17) Before starting the work, the work site may be dressed and cleared by cutting all sorts of jungle, shrubs etc for which no extra payment will be made
- 18) Error or incomplete Tender Form will be summarily rejected without assigning any reason whatsoever.
- 19) Bidder(s) may be asked to submit rate analysis for items where the quoted rates are either below or above 5% than the estimated cost. Such bids may also be considered as null and void if there is a reason to believe that the Bidders have formed a cartel and rates have been manipulated, unbalanced or unreasonable.
- 20) Successful Bidder will have to execute a formal contract on a Non-Judicial Stamp paper within seven days from the receipt of "Letter of Acceptance" with the Gram Panchayat wherein the description, specification, quantity, date of completion of work, other mandatory conditions and ESMF (Environmental and Social Management Framework) issues shall be detailed. Failure to execute the contract will lead to automatic cancellation of the bid.
- 21) The intending Tenderers or their authorized representative may remain present at time of opening of tender in the office of the Prodhan, Bara-Saota GP
- 22) Quotaed rate shall be inclusive of all charges including royalty, GSTIN, tools charges, transportation etc.
- 23) The quoted rates shall remain valid for a period of 90(ninety) days from the date of eNIT and the contractor will be liable for execution of work in accordance with the quoted rates or any other terms & condition as recorded by the bidder.
